VESTING ORDER

Vesting Order dated the *8th* day of *June* 2017

WHEREAS the land described in the Schedule hereto and shown on the map attached hereto which said map has been marked Drawing Number LR/11/17 being the map attached to Vesting Order Dev 2017/1 and sealed with the seal of South Dublin County Council (hereinafter referred to as “the housing authority”) is land to which the South Dublin County Council (Old Knocklyon Road) Order, 2016 relates, and the said order has become operative in so far as it relates to the said land:

AND WHEREAS the local authority have, at least six months prior to the date of this order, entered on and taken possession of the said land in accordance with the powers conferred upon them by section 80 of the Housing Act, 1966, as applied by section 10 of the Local Government (No. 2) Act, 1960 (as substituted by section 86 of the Housing Act, 1966):

AND WHEREAS-

- a) The several interests in the said land have not been conveyed or transferred to the local authority,
- b) The local authority consider that it is urgently necessary, in connection with the purposes for which they have been authorised to acquire the land compulsorily, that the acquisition of the land should be completed, and

- c) The local authority have made a proper offer in writing to each person having an interest in the said land who has furnished sufficient particulars of his interest to enable to make a proper offer for such interest:


NOW THEREFORE the local authority in exercise of the powers conferred upon them by section 81 of the Housing Act, 1966, as applied by section 10 of the Local Government (No. 2) Act, 1960, as substituted as aforesaid, hereby order that the said land shall, on the ^{30th} day of June 2017, VEST in the local authority in fee simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind (other than any public right of way).
