PROPOSED LINK ROAD BETWEEN THE AYLMER ROAD AND PEAMOUNT ROAD (R120) IN THE TOWNLANDS OF WESTMANSTOWN AND PEAMOUNT

Pursuant to the requirements of the above, notice is hereby given of the proposal to provide a link road between the Aylmer Road and Peamount Road (R120) in the Townlands of Westmanstown and Peamount as described below.

- A link road of approximately 1.15km in length, with a cross-section of two 4.5metre wide lanes, two 1.5 metre verges and one 2.0 metre footpath;
- A roundabout at the junction of the link road with the R120 Regional Road;
- A roundabout at the junction of the link road with the Aylmer Road;
- An access from the Greenogue Business Park onto the roundabout at the Aylmer Road;
- Traffic signs, roadmarkings, public lighting, drainage and associated works; and
- Tie-in works with the existing road network.
