


PUBLIC NOTICE OF

LIMEKILN ROAD EXTENSION TO GREENHILLS ROAD.

Pursuant to the requirements of the above, notice is hereby given of the provision by South Dublin County Council of the above scheme and a description of the Works follows:

- Construction of approximately 330 metres of 9 metre wide carriageway between Greenhills Road and Limekiln Road.
- Construction of cycletracks and footpaths.
- Installation of signal cortrol at the junction of Limekiln Road Extension and Greenhills Road
- Provision of pedestrian lights.
- Provision of pedestrian and maintenance entrances to Tymon Park.
- Provision of drainage and associated features.
- Provision of public lighting, road markings and signage.

Details of the proposed scheme will be on display at:

- South Dublin County Council Offices, County Hall, Tallaght From 9.00am – 5.00pm Monday to Thursday and 9.00am – 4.30pm on Friday.
