FORM OF COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO.2) ACT 1960 (SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT 1966) AND AMENDED AND EXTENDED BY SECTION 222 OF THE PLANNING AND DEVELOPMENT ACTS, 2000-2015.

THE LOCAL GOVERNMENT (NO.2) ACT 1960, THE ROADS ACTS, 1993 – 2015

LOCAL GOVERNMENT ACTS 1925 – 2003 INCLUDING SECTIONS 11 AND 184 OF THE LOCAL GOVERNMENT ACT, 2001 AND PART XIV OF THE PLANNING AND DEVELOPMENT ACTS, 2000 - 2015 INCLUDING SECTION 213 AND 214 OF THE PLANNING AND DEVELOPMENT ACT, 2000.

**Order, 2015**

WHEREAS in pursuance of Section 10 of the Local Government (No. 2) Act, 1960, as substituted by Section 86 of the Housing Act, 1966 as amended by Section 6 and the Second Schedule to the Road Act, 1993 and amended and extended by the Planning and Development Act, 2000-2015 South Dublin County Council (hereinafter referred to as "the Local Authority") have decided to effect the acquisition of the land to which this order relates under the Housing Act, 1966 (as amended).

NOW THEREFORE it is hereby ordered that -

1. Subject to the provisions of this order, the Local Authority is hereby authorised:
  - a) to acquire compulsorily lands for the purposes of the construction of a road improvement scheme, and all ancillary works associated therewith, from the townland of Grange to the townlands of Adamstown, commencing at the R120 west of Nangor Road and concluding at the R120 Adamstown Road in townland of Adamstown, County Dublin and traversing the townlands of Grange, Ballymakailly and Adamstown, all in the County of Dublin, the lands described in Part I of the Schedule hereto which land is shown on the maps marked "**South Dublin County Council Compulsory Purchase (Adamstown Road (R120) Improvement Scheme) Order, 2015**" (Drawing No. CA 309) and sealed with the seal of the Local Authority and deposited at the offices of the Local Authority.
  - b) to temporarily acquire lands in Part II of the Schedule.
  - c) to extinguish the public rights of way described in the Part III of the Schedule hereto by order made after the acquisition of the land, where the said public right of way is over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.

The lands, rights of way, easements and other rights are described in Part I, Part II and Part III shown on drawings marked:

**“South Dublin County Council Compulsory Purchase (Adamstown Road (R120) Improvement Scheme) Order, 2015”** (Drawing No. CA 309) and sealed with the seal of the Local Authority and deposited at the offices of the Local Authority (hereinafter referred to as “the deposited maps”).

2. The land described in Part I and Part II of the Schedule hereto and coloured grey on the said map is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.

3. Subject to any necessary adaptations, the provisions of -

(a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and

(b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 265(3) of the Planning and Development Acts, 2000 to 2015), as modified by the Third Schedule to the Housing Act, 1966 are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.

4. This order may be cited as the:
